After-Hours Library Lock-In BEHAVIOR CONTRACT

We want everyone at our after-hours programs to have a fun and exciting time at the Library!

Teens will be expected to follow the guidelines listed below:

- You must arrive between 5:45 and 6:00 p.m. (Doors will be locked at 6:00 pm)
- You must be picked up between 8:00 and 8:15pm (NO exceptions). The Front doors to the Library will be unlocked at 8:00 pm. The parent or caregiver picking you up must come into the building to retrieve you.
- All food, snacks, and drinks must be kept in designated areas only.
- You must remain in the designated areas of the Library unless you receive permission from a staff member to move to another part of the building.
- You will follow the general Library rules and instructions of the Library staff members. You will be given two warnings. On your third warning, your parent/guardian will be called to pick you up.
- Bullying, horseplay, and violence of any kind will not be tolerated. In these instances, staff retains the right to forego warnings and call a parent for the removal of their teen from the Library.
- Please respect others by keeping your hands to yourself and not touching the belongings of others.
- Library staff will be on duty the entire program time. If you have any questions or concerns, please tell a staff person.
